REMOVAL FROM TRAINING: Trainer, at his/her sole discretion, may remove a pet from class if a hazard or threat of any nature to any other animal or person is present. No refund will be given under such circumstances.

LIABILITY: Owner agrees to indemnify and hold Judy Luther, Trainer and Trainer's employees/agents harmless from all liability for any loss, damage or injury to persons, animals or property arising from or related to Owner's pet. Owner agrees that Trainer shall not be liable for loss or damage to animal for any reason unless said loss or damage was a direct result of Trainer's negligence.
